## GEARRESTEER NA INBRAAK

Twee mans is gearresteer nadat hulle by twee primêre skole in Phiritona ingebreek het. Op Dinsdag, 14 Julie 2020 was die Welkom-polisiëringsreaksiespan besig om hul misdaadvoorkomingspligte na te kom in die Phiritona woongebied, Heilbron.

Hulle het omstreeks 03:00 te voet gepatrolleer in die Sizabantu informele nedersetting en twee verdagtes opgemerk wat sakke dra. Die polisielede het die verdagtes genader en versoek om hulle te deursoek.

Gereedskap en dwelms is in hul besit gevind. Daar is ook stroombrekers gevind wat later bevestig is dat dit gesteel is tydens 'n inbraak by die twee laerskole in Phiritona.

Die twee verdagtes van 32 en 38 jaar oud is gearresteer en aangekla vir die besit van vermoedelik gesteelde eiendom, die besit van dwelms, en aangekla vir die oortreding van die Rampbestuurswet, Regulasie 33 (1) (A), asook die versuim om tussen 21:00 en 04:00 by die huis te bly, tensy 'n noodsaaklike diens gelewer moet word, Regulasie 48 (2).
